NEW BUSINESS (30 min.)

Tuition and fees

Kim and Pastor Keith are working on a marketing and recruiting plan for this coming school year (2025-2026). Tuition will maintain the same rate, but user fees will increase by \$50 per student (covers technology repairs and replacements for laptops). Early registration is being encouraged, so the post-deadline fee will move from \$375 to \$500 for returning families. We plan to open up registration in February and announce upcoming registration at the end of January. Full day 5-days per week preschool tuition will match K-8 tuition starting next year.

In terms of childcare, the best plan moving forward is to increase enrollment in the infant program so that they can roll up into 2s and then into Pre-K.

Five-Two Decision

We are marrying the Five-Two process with turnaround strategies to promote growth and reverse decline for Trinity. We prefer to have Pastor Keith stay with us for the duration of the Five-Two process and the success of finding the right replacement Senior Pastor.

We entered Executive Session at 7:13 P.M. and exited at 7:24 P.M.

Organization Strategic Imperatives

Turnaround Strategies: Turning around decline in Attendance, Giving, Engagement & Enrollment

Pastor encourages us to read "Canoeing the Mountains" by Todd Bolsinger – about Lewis and Clark. All of us are in a post-Truth, post-church culture, and it requires a grand sense of adventure.

We need to work on giving to the general budget (whether in worship or online). There must be a loving, trusting relationship between Pastor Keith and us, so that the congregants can also see the integrity of their giving. Teresa and Pastor Keith are going to work on a campaign to bolster online giving. Like in Mark 6, find what the community has, and then it will multiply in Jesus's hands.

We need to have a push to reinvigorate small groups and small group culture.

We have a hole – we need to do something multi-generational to recover the hole. Pastor Keith is working with staff on an inter-generational experience to fill this hole.

How do we build a culture where we are more spiritually mature than speaking our truth without love?

Pastor Keith plans to dedicate the activity room to youth, who can also use the adjoining FLC and gym to overflow.

Pastor sees a need for Trinity to follow the Biblical pattern of giving, starting with the \$1.2 million from the community center sale. He would like to tithe \$125,000 to LINC Chicago in honor of Trinity's 125-year anniversary. Kim also strongly advocated that we commit to fund a teacher for every grade from the \$1.2 million to show support for school growth.

"From now until the Lord takes you home, being a leader at Trinity is going to be intense." - Pastor Keith
